What is a Kinetica Freezeguard 3* Kitemarked Euro Cylinder?

We've been anticipating these changes and have developed a range of locks that are already aligned with the new standard. In fact, our 3* euro cylinders – Kinetica Freezeguard have already achieved the BSI KITEMARK TS007-1:2024 certification, we believe making us the first in the industry to meet this new benchmark. We're making it easy for customers to upgrade at their own pace, ensuring that compliance doesn't come with unnecessary stress or rushed decisions and costs."

At the heart of the cylinder's advanced defence capability lies an ingenious cam system and liquid and gas vents that protects against cylinder freezing and gluing.

What else is included?

The cylinder comes with a key fob which includes a QR code. Customers can register the cylinder on our website to activate their registration and Free maintenance updates from us. What's more, customers will also have access to 'My Keys.' This allows the customer to keep a record of their key number and an image, so if they ever lost all of their keys, they can log in to the website and simply take the key number and image to a key cutter to get cut. This will save them the expense of having to replace their cylinder!

USER INFORMATION

This cylinder offers resistance to the commonly used types of attack. No specific security hardware is required but installing this three-star cylinder in conjunction with security hardware complying with TS 007 will increase attack resistance still further. Security hardware can be of several types, including a handle with a reinforced backplate, an escutcheon or a device which is concealed behind the handle backplate. In all cases, the purpose is to protect your cylinder from force attack.
